Data Security

China Connect takes every precaution to protect your information. When you submit personal information via China Connect Website, your information is protected both online and offline. For example, when our registration form asks you to enter personal information, the information is protected during transmission by an industry standard high level of encryption - 256-bit SSL.

Any information you provide us is stored on Servers hosted in Germany at the China Connect premises, which are controlled by China Connect in a secure environment, in a locked facility so as to safeguard your information and avoid any data loss to the extent possible, or in the European Economic Area (EEA) zone in accordance with applicable laws and regulations.

Changing, updating personal information and Data Retention
